Deals closed across a diverse group of pay-TV, OTT, consumer electronics and semiconductor customers in both domestic and international markets




Revenue of \$83.2 million, adjusted EBITDA of \$51.7 million and paid down \$20.1 million on our term loan

DAZN, a leading OTT provider of global sports programming, signed a new multi-year license agreement for access to our media portfolio


Enseo, Freeview Australia, Massillon Cable, and TechniSat all renewed their license agreements for multi-year terms


